Both the abstracts and full texts of the papers will be subject to peerreview. While the abstracts of the papers will be published by the University in an electronic book format, full texts of the papers will be published in Ankara Yıldırım Beyazıt University’s Journal of Commercial and Intellectual Property Law. Full texts of the papers presented at the symposiums must be prepared in article format and in accordance with the author guidelines of the Journal of Commercial and Intellectual Property Law available at dergipark.org.tr/tfm.
